The parents made a specific recommendation, "to require all Fairfax County public school teachers to take courses in human relations." teachers to take courses in human relations."

This group met and outlined plans for contact with Gulf-Reston to discuss specific issues about the participation of Blacks in all aspects of Reston development. A LOOK AT FOCUS '72---Focus has had a busy year: i.e., conferring with our local schools administrators, meeting with county leaders and associations on sickle cell testing and other educational matters, denouncing a "Slave Sale", the Mad-Hatters' Spring Fling and other socials, the Annual Black Arts Festival. and publication of the Focus Newsletter!

And the year is not over! The membership meeting on this Thursday is important in that we are nearing final reports and looking ahead to next year by electing Steering Committee members. Do you recall last years's swinging Christmas Party? Well, we're going to swing again on December 30 -- place to be announced. So, reserve these two dates: December 14--Meeting and December 30--Party!

STEERING COMMITTEE--Of the eight (8) above names nominated for the Steering Committee, four (4) will be elected. Any further nominations may be made by calling Syliva Marshall, Mona Head and/or Joan Cooper. Nominations can also be made from the floor. The various Committee Chairmen make up the remaining members of the Steering Committee. SICKLE CELL TESTING---At the Focus membership meeting on November 9, the regular agenda was tabled in order to discuss the sickle cell compulsory testing law passed by the Virginia Legislature; consider the ramifications of the new law and actions parents and/or Focus could take regarding the law. Objections were made on the basis of:

-compulsory testing as opposed to voluntary testing;

-possible psychological damage by testing only young Black school children;

-insensitive approach of school adminstrations in carrying out the ruling:

-invasion of privacy by maintaining tests results on health records.

Two actions were voted by the members present: Focus will proceed immediately to file an injunction against the law and a committee was appointed to contact a lawyer. The members appointed were Dr. George Tolbert, Attorney Grover Hankins, Dr. Lewis Marshall and Mona Blake of the Fairfax County School Board. The American Civil Liberties Union had already been contacted regarding the matter. Mona Head was appointed chairman of a Task Force of Parents to go to the schools in our area and to explain to the principals our concern over the testing program and other related communications-films, etc.

EDUCATION COMMITTEE MEETS---On Nov. 18 the Education Committee, chaired by Alene Smith, called a special meeting at which representatives from all area schools were present. Also present war the Associate Superintendent of Schools, a representative from the Health Dept., the School Board Attorney, the Health Education Specialist, and a Human Relations Coordinator. Fred Humphries presided over the meeting. Several important points were made:

-as a result of Mona Blake's objections to the Virginia Legislatures bill, Fairfax County Schools agreed to have parents sign consent forms before testing and not to have the results of the test on the child's records; though the test are mandatory there will be no expulsion from school; -Fairfax School Board passed a resolution to delay further testing in schools until the Legislature meets. This resolution will be given to the Legislature in Dec. by the Superintendent. Some schools have been slow in getting the communication to parents.

-State Health Dept. agrees with Focus' position;

-County Health Dept. has already made 1,473 tests, of which 113 were positive. Focus will be in contact with the Health Dept. concerning records, genetic counseling, etc of those already tested.

-Legislature made no appropriation of funds for testing, so

tne County is absorbing all cost.

-Elias Blake and Lewis Marshall made presentations in opposition to the law at Governor Holton's Conference

The Injunction Committee reported that they were in touch with ACLU lawyers and the price of \$400 was quoted-less with volunteer clerical help. The legal issues to be attacked would be mandatory testing, invasion of privacy and violation of civil rights. The Committee is presently soliciting position papers reflecting psychological, long-range impact and the social-educational impact; getting expert witnesses and counselors from across the country who will be willing to testify. This necessary research has cost the delay in filing the injunction.
