CAROL BRADLEY; presently Secretary, Black Focus Board of Directors:
"I would like to see FOCUS involve all segments of
the black Reston community, especially through programs
provided to stimulate teenagers."

THOMAS BUTLER; worked with Black Focus Festival for the past two years:

"The time has past for black organizations concerned with socializing. It is now time for FOCUS to become a viable organization and let its voice be heard by all Virginia regarding issues affecting its black citizens."

BRENDA METZE; worked with FOCUS festivals over the past years:
"I believe that it would be desirable to extend
the activities of FOCUS to include blacks living in
Herndon and other surrounding areas."

PETE PETERSON; presently working with black teenagers in Fox Mill and Laurel Glade Apartments:

Mr. Peterson has stated that he would like to see FOCUS become an organization that concerned itself with all black citizens in the community, especially young people. This goal can only be accomplished by FOCUS members becoming aware and acknowleding the entire black population of Reston.

BEVERLY SHARP; presently Chairman, Board of Directors, Reston Black Focus:

"I want to continue working toward two objectives:

1) strengthening the operating committees so that Reston
Black Focus can deal more effectively with the issues
we continue to face as blacks in Reston and in Fairfax
County; and 2) obtaining tax-exempt designation from the
I.R.S. so that we can reduce the cost of mailing the
newsletter from 10¢ each to less that 2¢ each, and solicit
tax deductible contributions and grants. I am interested
in taking care of business at both ends--strengthening our
substantive program, and improving our financial posture."

CHARLES SMITH, Tresurer, Reston Black Focus, Board Member: "I would continue working with Reston Black Focus to make it a bona fide corporation on a state level so that FOCUS will get broader recognition. I see FOCUS as an organization will will maintain the black heritage that we were essentially organized for and make both the black and white public aware of what we are working toward. I think FOCUS whould be more involved in benevolent programs, mainly in the black communities immediately surrounding Reston."

CLARESTINE SUMMEY, member Boad of Directors; presently newsletter coordinator:

> "I will give time, work and cooperation to the purpose of Reston Black Focus, Inc."

ROCHELLE THOMPSON, worked with the Entertainment Committee, Reston Black Focus Festival, 1974:
