

The James M. Buchanan Lecture is dedicated to the public choice discourse and draws its inspiration from the pioneering scholarship of Professor James M. Buchanan, particularly his development of the contractual and constitutional bases for the theory of economic and political decision making.

James M. Buchanan

Advisory General Director, Center for Study of Public Choice, and Distinguished Professor Emeritus, George Mason University and Virginia Polytechnic and State University

Buchanan was the cofounder, with Warren Nutter, of the Thomas Jefferson Center for Political Economy at the University of Virginia, and also cofounder, with Gordon Tullock, of what later became the Public Choice Society. The Center for Study of Public Choice was created in 1957 at the University of Virginia and was initially called the Thomas Jefferson Center for Studies in Political Economy. In 1969, the Center was reconstituted at Virginia Tech under its present name and in 1983, the Center and Professor Buchanan came to George Mason University. Buchanan was awarded the Nobel Prize in Economic Sciences in 1986.

Sandra Peart

With David Levy, she is co-editing a collection of papers from the first five years of the Summer Institute, The Street Porter and the Philosopher: Conversations on Analytical Egalitarianism.

Deirdre McCloskey

Distinguished Professor, University of Illinois at Chicago and Erasmus Universiteit, Rotterdam

McCloskey teaches economics, history, and English at the University of Illinois at Chicago; and philosophy, economics, and art and cultural studies at Erasmus Universiteit of Rotterdam. She is the author of 20 books on economics, British economic history, and the rhetoric and philosophy of economics. Her most recent work, *The Bourgeois Virtues: Ethics for an Age of Capitalism*, will be available in June 2006.

David Levy

Levy's research specialties include the relationship of spending on research and development to productivity and the role of ethics in statistical estimation. Levy co-authored "The Vanity of the Philosopher": From Equality to Hierarchy in Post-Classical Economics with Sandra Peart.
