I have practiced architecture both as a principal and with other firms for the past six years. During that time, I have been responsible for the design and construction of buildings costing in excess of \$17,000,000.00. My own office was organized in August 1968. We have maintained offices in the Central Business District of the District of Columbia since our inception. The office draws heavily upon the wealth of knowledge and experience acquired by Austin Spriggs in New York City and Washington, D. C. In the past two years we have been awarded commissions in excess of \$4,000,000.00.

Our work has included the design of large apartment projects, school facilities, community centers, community parks, and planning in the burned out Fourteenth Street Corridor.

Our office, founded in the late 1960s looks forward in this new decade with hope and expectation. We expect continued commissions in the areas of housing and institutional design. However, in concert with other firms we are expanding and diversifying our practice to include the new fields of space design, mass transportation, and community health facilities.
